

# **END USER LICENCE AGREEMENT**

## **Online Use Music Licence (Non-Exclusive)**

**This End User Licence Agreement (Agreement) is entered into between Night Wolf and EscaVolt Records (Licensor) and the purchaser (Licensee).**

**By purchasing, downloading, or using the licensed music, the Licensee agrees to be bound by the terms of this Agreement.**

### **1. Grant of Licence**

**Upon payment of the licence fee, the Licensor grants the Licensee a non-exclusive, non-transferable licence to use the licensed sound recording solely within the permitted scope defined in this Agreement.**

**This licence does not transfer ownership of the sound recording or any underlying rights.**

### **2. Permitted Use**

**This licence permits use of the licensed sound recording in online and web-based content only, including but not limited to:**

- **YouTube videos**
- **Social media content**
- **Websites and web pages**
- **Podcasts and online audio content**
- **Online advertisements (non-broadcast)**
- **Internal or corporate online media**

**The licence allows use of the licensed sound recording across multiple projects, provided all usage remains within the permitted scope of this Agreement.**

### **3. Prohibited Use**

**The Licensee may not:**

- **Use the licensed sound recording in TV, film, broadcast, cinema, or theatrical exhibition**
- **Use the licensed sound recording in video games or interactive media**
- **Release, distribute, or sell the sound recording as music**
- **Create derivative works, including remixes, edits, new vocal recordings,**

or altered versions

- Claim ownership or authorship of the sound recording
- Register the sound recording with any distribution, content identification, or royalty collection systems

#### **4. Royalties and Rights**

All copyrights, neighbouring rights, publishing rights, and performance rights remain the property of the Licensor and the original rights holders.

Any applicable royalties generated from licensed use are retained by the rights holders. The Licensee is not entitled to collect or claim royalties related to the sound recording.

#### **5. Content ID**

The licensed sound recording may be registered with automated content identification systems, including Content ID.

Automated claims may occur as a result of such systems. Upon proof of valid licence purchase, the Licensor will release or whitelist applicable claims for the Licensee's approved use.

The Licensor retains full control of all content identification systems and is not required to disable Content ID globally.

#### **6. Credit**

Where reasonably possible, the Licensee agrees to credit Night Wolf and EscaVolt Records in the content description or credits.

#### **7. Termination**

This licence may be terminated immediately if the Licensee breaches any term of this Agreement. Upon termination, all use of the licensed sound recording must cease.

#### **8. Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the United Kingdom.

## **9. Contact and Further Licensing**

**For any use outside the scope of this licence, including TV, film, games, broadcast, or bespoke projects, the Licensee must contact the Licensor via the official website for a custom quote and written approval.**
